Any foreign person, as defined in Section 442.592.1, RSMo, who potentially will acquire or transfer any interest in agricultural land in Missouri, other than a security interest, shall submit this application and report form to the Director of Agriculture, PO Box 630, Jefferson City, Missouri 65102-0630. (See 2 CSR 110-4.010)

Please note: This application and report form is not required for the acquisition or transfer by a foreign person of an interest in agricultural land for the extraction, refining, processing, or transportation of oil, gas, coal or lignite.

This application and report form must be approved by the Director of Agriculture before the acquisition or transfer can be completed. Subsequent application and report forms shall be filed upon any change in information contained in the original application and report as required in Sec. 442.592.2, RSMo.

Any person who fails to file an application and report form as required by Sec. 442.592 is liable to the state in civil penalty.
